

Preamble

Under the visionary leadership of **Honb. Dr. Akshai Aggarwal sir**, Vice chancellor of GTU, University has organized nearly 72 workshops in last four years and by that way provided training to 4,850 faculty members for the Basic to advance level of IPR as well as conducted workshops for students too. GTU has introduced "Patent Search and Analysis Report (PSAR) Generation" compulsory to BE (Sem 7) and M. Pharm (Sem 3) students. Further, "Patent Drafting Exercise (PDE)" is introduced in BE (Sem 8). Due to this facilitation support provided by GTU, **354 patents** have been filed by GTU students and faculty member in last 4 years.
